Janet Ancel, Calais

Janet grew up in Calais and attended school in Maple Corner when it was a one room school. She is a graduate of Stanford University (BA, English and History) and the University of Denver (MSW, JD). After many years working with the Legislative Council, Janet was appointed Legal Counsel to Governor Howard Dean and later as Tax Commissioner in the Dean Administration. She is no longer in active practice and now serves in the Vermont House of Representatives where she is Chair of the Ways and Means Committee, Chair of the Joint Fiscal Committee and a member of the Emergency Board, the Health Reform Oversight Committee and the Joint Transportation Oversight Committee.
